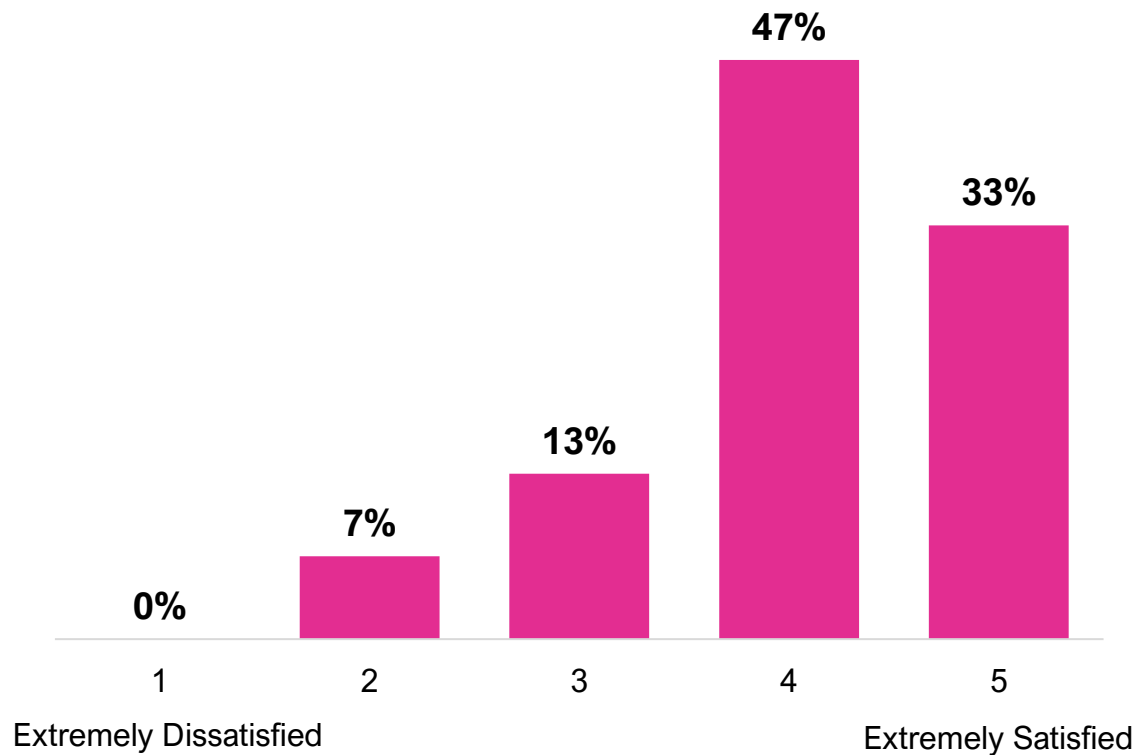

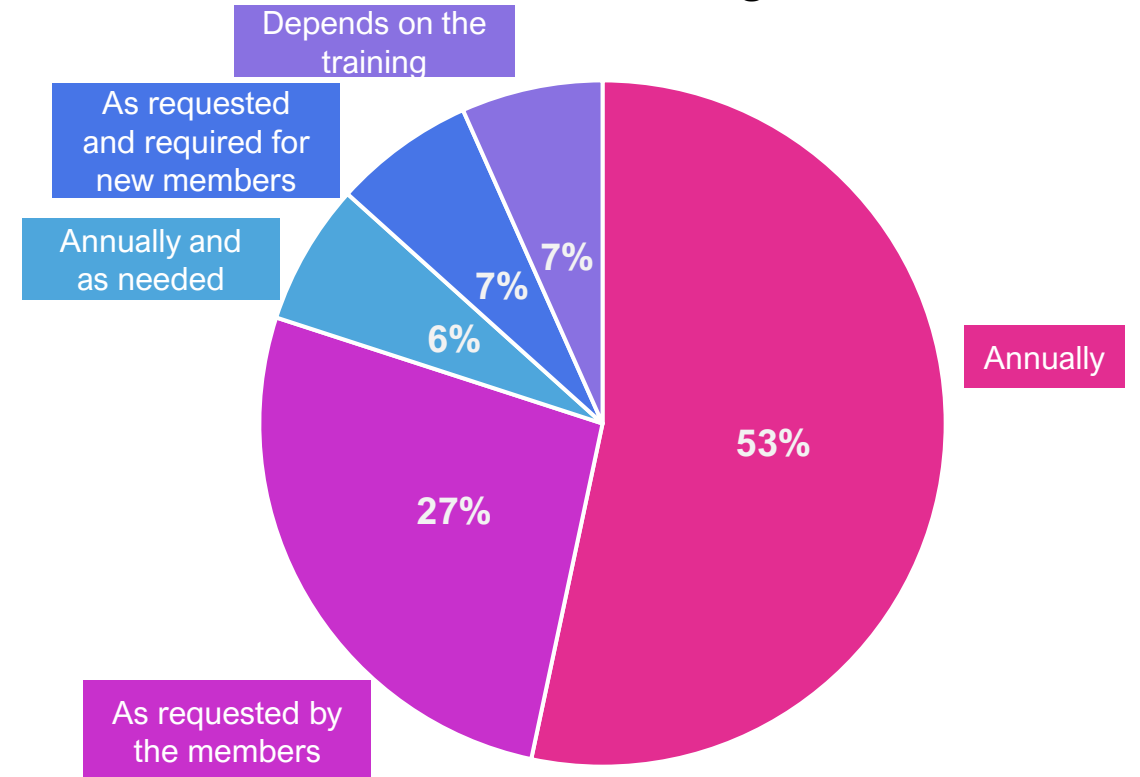

Satisfaction with April 17 Training

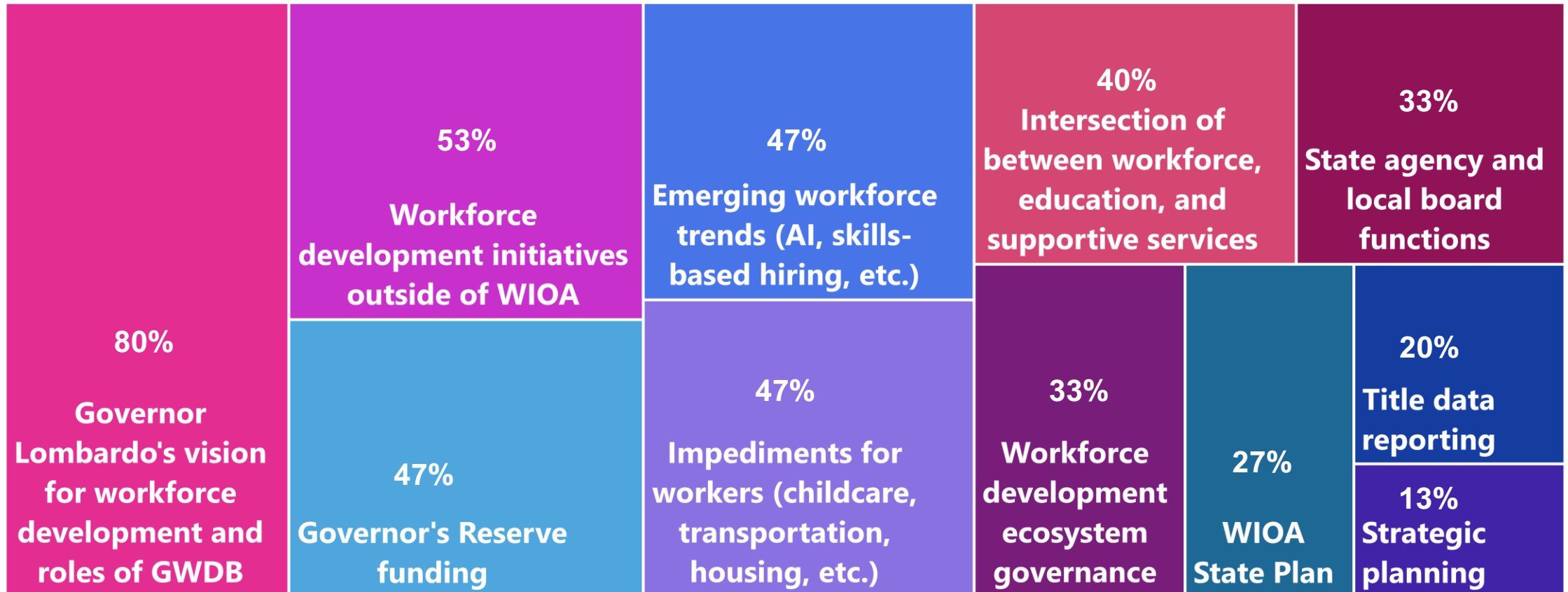


Frequency of a comprehensive board training
